- Both Technical Bid and Financial Bid should be submitted in technical and financial folder concurrently and duly digitally signed by the Quotationer through the website <http://wbtenders.gov.in>. The documents submitted by the bidders should be properly indexed.
- The Bid should be submitted online on or before the date and time given in this e-NIQ.**
- The FINANCIAL OFFER of the prospective quotationer will be considered only if the TECHNICAL Document of the quotationer found qualified by the Quotation Inviting Authority. The decision of the Quotation Inviting Authority will be final and absolute in this respect. The both list of Responsive and Non-Responsive Bidders will be displayed in the website and also in the Notice Board of the office of The **West Bengal Police Housing and Infrastructure Development Corporation Limited.**

6. Eligibility criteria for participation in the Quotation:

- i) All categories of prospective Bidders shall have to be manufacturer of Electro- Mechanical Components Sewage Treatment Plant or shall have experience of execution of similar nature of work.
- ii) No conditional / Incomplete Quotation will be accepted under any circumstances.
- iii) Where there is a discrepancy between the unit rate & the line item total resulting from multiplying the unit rate by the quantity, the unit rate quoted shall govern.
- iv) **Prevailing safety norms has to be followed so that LTI (Loss of time due to injury) is zero.**
- v) Valid PAN issued by the IT. Dept, Govt. of India, Valid Professional Tax Receipt Challan, Trade Licence, **Valid 15-digit Goods and Service Taxpayer Identification Number (GSTIN) under GST Act, 2017**, are to be accompanied with the Technical Bid document. Income Tax Acknowledgement Receipt for assessment year (2018-2019) to be submitted.
- vi) Where an individual person holds a Digital Signature Certificate in his own name duly issued to him against the company or the firm of which he happens to be a director or partner or employee, such individual person shall, while uploading any quotation for and on behalf such company or firm, invariably upload a copy of registered power of attorney showing clear authorization in his favour, by the rest of the directors of such company or the partners of such firm to upload such quotation. The Power of Attorney shall have to be registered in accordance with the revisions of the Registration Act, 1908.

7. No price escalation/adjustment will be allowed. The bidder should quote rate accordingly.
8. In connection with the work, Arbitration will not be allowed.
9. Bids shall remain valid for a period not less than 120 (One hundred twenty) days after the dead line date for Bid submission. Bid valid for a shorter period shall be rejected by the QUOTATION Inviting Authority as non-responsive. If the Bidders withdraw the bid before the period of bid validity without giving any satisfactory explanation for such withdrawals, the earnest money as deposited will be forfeited forthwith without assigning any reason thereof.
10. All the forms and Affidavits attached with this e-NIQ should be duly filled up and digitally signed and will be uploaded with the Quotation.
11. **Earnest Money:** The amount of Earnest Money as given in the List of Work should be remitted through online process as per Finance Deptt. G. O. No. 3975-F(Y) dated 28.07.2016.
12. **Security Deposit:** In respect of successful Bidders, the Earnest Money after acceptance of QUOTATION shall be converted as a part of the Security Deposit. In all cases the amount of recovery of the Final Bill will be so adjusted as to make the total amount of Security Deposit equivalent to 10% (Ten percent) to the value of work so executed.
13. The Bidder, at his own responsibility and risk is encouraged to visit and examine the site of works and its surroundings and obtain all information that may be necessary for preparing the Bid and entering into a contract for the work as mentioned in the Notice Inviting Quotation, before submitting offer with full satisfaction, the cost of visiting the site shall be at his own expense.
14. The Quotation Inviting Authority reserves the right to accept or reject any offer without assigning any reason whatsoever and is not liable for any cost that might have incurred by any Bidders at the stage of Bidding.
15. **Refund of EMD:** The Earnest Money of all the unsuccessful Bidders deposited along with the Quotations will be refunded by as per norms.
16. **Defect Liability Period:** The successful Tenderer will be liable for maintenance of the work during the defect Liability period of 3(three) years to the satisfaction of the Engineer-in-Charge at his own cost from the date of

completion of the work. If any defect/damage is found during the period as mentioned above the contractor shall make the same good at his own cost / expense to the specification at par with instant project work. Failure to do so, penal action against the Agency will be imposed by the Tender Inviting Authority as deemed fit. The Agency will have to quote his rate considering the above aspect.

However, the defect liability period should not be considered as completed in any case before handing over of the project. No Security Deposit shall be refunded before handing over the work.

The date of completion of the work shall be the date of signature of the final bill by the concerned Executive Engineer.

17. **Refund of Security Deposit:** Security Deposit of the Contractor held with the Corporation shall be released in the following manner, if not forfeited under condition(s) of contract:

I. 30% of the security deposit shall be refunded to the contractor on **expiry of 1st year of the defect liability period.**

II. Further 30% of the security deposit shall be refunded to the contractor on **expiry of 2nd year of the defect liability period.**

III. The balance 40% of the security deposit shall be refunded to the contractor on **expiry of the defect liability period.**

However, no Security Deposit shall be refunded before handing of the work.
